Initiation: \$425 One-time, non-refundable fee.

Equity: \$475 One-time Membership Equity Fee that is refunded when a membership is sold if the member has conformed to the association's by-laws including timely payment of annual dues. The fee is forfeited if the member does not pay annual dues on time. Refunds are made only after the membership share is resold and thus may be delayed.

Annual Dues: \$595 Annual fee that may be increased by the Board of Directors by up to 10% in any one year.
